- 5. Potential for printer control and management.

- 6. Cost efficient supplies—low cost per copy
- 7. Easy availability of supplies at all times

Track record

- 8. Track record of installations of similar equipment
- 9. List of customers using similar equipment

After-sales-service and references

- 10. Confirmation of ability to provide reliable after sales service in order to ensure minimum equipment downtime.
- 11. List of five customers that have had service contracts in place for a minimum of three years.

Training and certification

12. Confirmation of training and certification on all equipment proposed. Where firms are located off-island, training and use of local personnel would be an asset.

13. Options for staggered implementation.

14. Attractive payment terms.

15. Local firms must ensure that they obtain a Tax and Social Security Compliance Certificate. Foreign firms must make provision for a 20% Withholding Tax on contract payments.
