

## Political Economy of Public Procurement

## Average Government Spending


- ▶ CARICOM in General 15% –20% of GDP



## What Effective Public Procurement Can do

**Competition** – Competitive public procurement practices are essential for efficiency in public spending;

**Transparency** – Competitive and transparent procurement markets help public authorities acquire cheaper, better quality goods, at lower costs;

## What Effective Public Procurement Can do

Non-Discrimination - Open, non discriminatory

and transparent procedures can help boost the competitiveness of firms operating in the public procurement market

## Governance and Accountability – Increased

## What will happen if Policy is effectively implemented

- Increased Cross border competition
- Price Savings derived from implementation of efficient procedures, economies of scale, value for money, increased competition
- Triple transparency
- Increased efficiency
- Budget deficit reduction
- Resources Allocation 1. improved. 2. use

#### What's at Stake

- MSMEs Remain Small and Micro limited market in which to grow
- ▶ 22-30 Billion EC\$, PP Market will remain restricted to mostly national supplier
- Intra-regional trade will be restricted

#### What's at Stake

- Harmonisation will become increasingly complex as CC Member States put national legislation in place (9 Countries with developments in the pipeline)
- Building of the Regional electronic Public Procurement platform could be compromised if the national electronic systems are put in place which do not "speak" to each other.
- Multi-million dollar exercise to develop and maintain electronic platforms

## Objective of the FRIP

• objective of the FRIP is to identify and set out the conditions necessary for full integration of the national procurement markets;

- ▶ 15–20% due to Efficiency
